ORDINANCE NO. 2027

AN ORDINANCE AMENDING SECTION 33-8-5 OF THE STREET REGULATIONS OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS, AS FOLLOWS:

WHEREAS, Section 33-8-5 of the Revised Code of Ordinances **currently** states as follows:

33-8-5 **SNOW ROUTE.** No one shall park any motor vehicle or trailer on the following streets between the hours of **4:00 A.M. to 6:00 A.M.** when the accumulated depth of snow is **two (2) inches** or greater:

- (A) State Street from Maple Street to Cedar Street;
- (B) Maple Street from State Street to Central Street;
- (C) Spruce Street from State Street to Central Street;
- (D) Pine Street from State Street to Central Street;
- (E) Cedar Street from State Street to Central Street;
- (F) Spruce Street from State Street to Front Street;
- (G) Pine Street from State Street to Front Street;
- (H) Cedar Street from State Street to Front Street.

All such illegally parked vehicles shall be towed and the owner of the vehicle shall pay all expenses of towing and storage of the vehicle.

The penalty for violation of any provision of this Section shall be a fine of not less than **One Hundred Dollars (\$100.00)** nor more than **Five Hundred Dollars (\$500.00)** for each violation thereof. Each day of the violation shall constitute a separate offense. Said offense shall be a business offense, and shall be enforceable against the owner, lessee, or lessor, and operator of said equipment. **(Ord. No. 916; 10-11-04)**

BE IT ORDAINED, that the above-mentioned paragraphs shall be deleted from the City Code.

BE IT ORDAINED that the following shall amend and replace Section 33-8-5 of the Revised Code of Ordinances of the City of Nokomis as follows:

33-8-5 **SNOW ROUTE.** No one shall park any motor vehicle or trailer on the following streets between the hours of **4:00 A.M. to 6:00 A.M.** when the accumulated depth of snow is **two (2) inches** or greater:

- (A) State Street from Maple Street to Cedar Street;
- (B) Maple Street from State Street to Central Street;
- (C) Spruce Street from State Street to Central Street;
- (D) Pine Street from State Street to **South Street**;

- (E) Cedar Street from State Street to Central Street;
- (F) Spruce Street from State Street to Front Street;
- (G) Pine Street from State Street to Front Street;
- (H) Cedar Street from State Street to Front Street.

All such illegally parked vehicles shall be towed and the owner of the vehicle shall pay all expenses of towing and storage of the vehicle.

The penalty for violation of any provision of this Section shall be a fine of not less than **One Hundred Dollars (\$100.00)** nor more than **Five Hundred Dollars (\$500.00)** for each violation thereof. Each day of the violation shall constitute a separate offense. Said offense shall be a business offense, and shall be enforceable against the owner, lessee, or lessor, and operator of said equipment.


