



AN ORDINANCE AMENDING CHAPTER 33 STREET REGULATIONS, ARTICLE II - GENERAL REGULATIONS, SECTION 33-2-9 OBSTRUCTING STREET OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS and AMENDING ADMINISTRATION, APPENDIX "A", **VIOLATION PENALTIES, ADDING SECTION: STREET REGULATIONS — CHAPTER 33 OBSTRUCTING STREETS 33-2-9**

WHEREAS, it is deemed to be in the best interest of the residents of the City of Nokomis, Montgomery County, Illinois to amend Section 33-2-9 and Administration Appendix "A" Violation Penalties of the code,

WHEREAS, upon Motion duly made and seconded, the following is adopted by the City Council:

WHEREAS, Section 33-2-9 of the Revised Code of Ordinances currently states as follows:

33-2-9 **OBSTRUCTING STREET.**

It shall be unlawful to deposit any material on any street which may be harmful to the pavement thereof, or any waste material, or any grass clippings, or to cause a lawn mower to blow grass clippings onto a street or any other articles such as glass which may cause injury to any person, animal or property.

No person shall place or cause to be placed or erected on any public ground, or in any public street, alley or sidewalk in the City, any debris,

materials, or obstruction, except as may be permitted by this Code.

It shall be the duty of the Police Department to exercise a vigilant supervision over such places and to notify any person found making such deposit or responsible for same to remove the offending matter at once.

BE IT ORDAINED that the above-mentioned paragraphs shall be deleted from the City Code.

BE IT ORDAINED that the following shall amend and replace Section 33-2-9 of the Revised Code of Ordinances of the City of Nokomis as follows:

33-2-9 **OBSTRUCTING STREET.**

It shall be unlawful to deposit any material on any street which may be harmful to the pavement thereof, or any waste material, or any grass clippings, leaves or yard waste, or to cause lawn equipment to blow grass clippings, leaves or yard waste onto a street or any other articles such as glass which may cause injury to any person, animal or property. (B)

No person shall place or cause to be placed or erected on any

public ground, or in any public street, alley or sidewalk in the City, any debris, materials, or obstruction, except as may be permitted by this Code.

It shall be the duty of the Police Department to exercise a vigilant supervision over such places and to notify any person found making such deposit or responsible for same to remove the offending matter at once or be fined.

Penalties. Any person violating the provisions of this ordinance shall be subject to a fine from Seventy-Five Dollars (\$75.00) to a maximum of Seven Hundred Fifty Dollars (\$750.00) for each violation.

BE IT ORDAINED that the following shall amend ADMINISTRATION, APPENDIX "A", VIOLATION PENALTIES, ADDING Section: Street Regulations - Chapter 33 Obstructing Streets 33-2-9 Obstructing a Street, First offense \$75.00 and Second offense \$150.00 of the Revised Code of Ordinances of the City of Nokomis.

BE IT ORDAINED, this Ordinance shall be published in pamphlet form and take effect thereafter.
