AN ORDINANCE AMENDING ARTICLE IV - UTILITY RATES, DIVISION II - WATER RATES, SECTION 38-4-11 RATES ESTABLISHED AND DIVISION III WASTEWATER SERVICE CHARGES, SECTION 38-4-33 USER CHARGE SYSTEM OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS

WHEREAS, it is deemed to be in the best interest of the residents of the City of Nokomis, Montgomery County, Illinois to amend Section 38-4-11 and 38-4-33 of the code;

WHEREAS, upon Motion duly made and seconded, the following is adopted by the City Council:

WHEREAS, Section 38-4-11 of the Revised Code of Ordinances currently states as follows:

BE IT ORDAINED that the following shall amend and replace Sections 38-4-11 and 38-4-33 of the Revised Code of Ordinances of the City of Nokomis as follows:

38-4-11 RATES ESTABLISHED. All users of the water distribution system shall pay a minimum monthly bill of Eight Dollars Seventy-Five Cents (\$8.75) service charge per billing period for users inside the City limits and Eighteen Dollars Seventy-Five Cents (\$18.75) service charge for users outside the City limits per connection to the system. The purpose of this minimum bill is to recover the fixed overhead costs associated with operating and maintaining the water service, based upon the amount of water consumed monthly as shown by the water meters.

Effective May 1, 2020 on bills having a due date of July 15, 2020:

- (A) WATER RATES INSIDE CITY
 - \$7.05 for each 1,000 gallons per month
- (B) WATER RATES OUTSIDE CITY

\$10.07 for each 1,000 gallons per month

- (C) WATER RATES BY TANK LOADS
 - \$.50 per 100 gallons
- (D) <u>VILLAGE OF COALTON</u>

\$5.66 per 1,000 gallons per month

A 1% rate increase will be applied to water rates per 1,000 gallons inside and outside city limits annually on May 1^{st} to account for inflation.

38-4-33 USER CHARGE SYSTEM. The following rates are established for the User Charge System:

(A) User Rate. All users of the Wastewater Facilities of the City of Nokomis shall pay a minimum monthly charge of Seven Dollars Twenty-Five Cents (\$7.25) per billing period for users inside the City limits and Twelve Dollars Twenty-Five Cents (\$12.25) per billing period for users outside the City limits for each connection to the system. The purpose of this minimum bill is to recover the fixed overhead costs associated with operating and maintaining the City's sewer system.

Effective May 1, 2020 on bills having a due date of July 15, 2020:

- (B) <u>Inside City.</u> \$6.30 per 1,000 gallons per month
- (C) Outside City. \$8.73 per 1,000 gallons per month
- (D) <u>Village of Coalton.</u> \$2.84 per 1,000 gallons per month

A fee of **\$5.00** shall be charged each month for each meter in service in the *Nokomis water or sewer system* whether said meter is located within or outside the city limits of the City of Nokomis. Said charge shall be added to each water bill when rendered.

A 1% rate increase will be applied to sewer rates per 1,000 gallons inside and outside city limits annually on May 1^{st} to account for inflation.
