**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE
CITY OF NOKOMIS, ILLINOIS, AS FOLLOWS:**

Section 24-3-1 and 24-3-3, Schedule "A" of the Revised Code of Ordinances of the City of
Nokomis, Illinois, is hereby amended by adding thereto the following:

SCHEDULE "A"

STOP INTERSECTIONS

In accordance with the provisions of Sections 24-3-1 and 24-3-3 of this Chapter, the following
streets are hereby designated as stop and through streets:

I. ONE AND TWO STOP STREETS.


CERTIFICATION
