## ORDINANCE AUTHORIZING LEASE OF MUNICIPALLY OWNED REAL PROPERTY

WHEREAS, the City of Nokomis, Montgomery County, Illinois, owns the following described real property:

Beginning at the Northern most point of Lot 1 of Block 25 situated in the Original Town, now City, of Nokomis, thence northwest parallel with Spruce Street 27 feet; thence Southwest parallel with State Street 55 feet; thence Southeast parallel with Spruce Street 27 feet; thence Northeast parallel with State Street a distance of 55 feet to the point of beginning, all situated in the City of Nokomis, Montgomery County, Illinois.

Also beginning at the intersection of the existing right-of-way line for the Southern Pacific Railroad at the intersection of the West side of Spruce Street thence Southeasterly parallel with Spruce Street a distance of 12 feet; thence Southwesterly parallel with State Street a distance of 55 feet; thence Northwesterly parallel with Spruce Street a distance of 12 feet; thence Northwesterly parallel with Spruce Street a distance of 12 feet; thence Northeasterly along the existing right-of-way line of the railroad to the point of beginning, all situated in the City of Nokomis, Montgomery County, Illinois.

WHEREAS, pursuant to Section 11-76-1 of the Illinois Municipal Code, 65 ILCS 5/11-76-1, it is hereby ordained by the Board of Commissioners of the City of Nokomis, Montgomery County, Illinois as follows:

- Section 1. The Board of Commissioners find as facts the recitals herein above set forth.
- Section 2. The Mayor is hereby authorized and directed to sign and the City Clerk is hereby authorized and directed to attest a Lease for the real estate described in Exhibit A hereto which Lease shall be for a period not in excess of twenty years together with the right to renew for an additional twenty years to the Nokomis Savings Bank, an Illinois corporation, for a rental of Two Thousand Dollars (\$2,000.00) for the twenty-year term.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
