ORDINANCE AUTHORIZING SALE OF REAL ESTATE

<u>Section 3.</u> Publication for bids having been made pursuant to law, and the only bidder, Brett Mills having offered the sum of \$10,505.00, it is hereby ordained the Mayor is authorized to execute all necessary documents, including a deed to Brett Mills, subject to 2005 real estate taxes payable in 2006.
