

ORDINANCE NO. 934

**ORDINANCE AMENDING ARTICLE III OF THE
ADMINISTRATION CODE OF THE REVISED CODE OF ORDINANCES
OF THE CITY OF NOKOMIS, ILLINOIS**

Be it ordained by the City Council of the City of Nokomis, Illinois that,

The ADMINISTRATION CODE of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by deleting the prior Article III (paragraphs 1-3-1 (A) through 1-3-1(E)) and replacing it with Article III (paragraphs 1-3-1 (A) through 1-3-1(E)) as follows:

(A) **Department of Public Affairs - Mayor.** The compensation for the Mayor shall be **Five Thousand Two Hundred Dollars (\$5,200.00)** per year.

(B) **Department of Accounts and Finance - Commissioner.** The compensation for the Commissioner of the Department of Accounts and Finance shall be **Three Thousand Six Hundred Dollars (\$3,600.00)** per year.

(C) **Department of Public Health and Safety - Commissioner.** The compensation for the Commissioner of the Department of Public Health and Safety shall be **Three Thousand Six Hundred Dollars (\$3,600.00)** per year.

(D) **Department of Streets and Public Improvements - Commissioner.** The compensation for the Commissioner of the Department of Streets and Public Improvements shall be **Three Thousand Six Hundred Dollars (\$3,600.00)** per year.

(E) **Department of Public Property - Commissioner.** The compensation for the Commissioner of the Department of Public Property shall be **Three Thousand Six Hundred Dollars (\$3,600.00)** per year.

Passed by a majority vote of the members of the City Council and approved by the Mayor of the City of Nokomis, Illinois on this 23rd day of October, 2006, to take effect at the beginning of the next term of office.


CERTIFICATION
