ORDINANCE REGARDING INTERGOVERNMENTAL AGREEMENT


WHEREAS, it is desirable that the City of Nokomis police roads owned by the Nokomis Township as follows:

Weaver Street between Walnut Street and Oberle Street, Sherman Street, West of Cedar Street; Alley running from Sherman Street South to Oberle Street; Hamilton Street from city limit West to Sewage Disposal Plant; Franklin Street from city limit West to dead end; Roadway connecting Walnut Street to the road at baseball diamonds in Nokomis Memorial Park.

WHEREAS, the City of Nokomis is willing to provide such policing and does desire to enter into an Intergovernmental Agreement;

WHEREFORE, it is hereby ordained that the City of Nokomis shall enter into an Intergovernmental Agreement with the Nokomis Township for the policing of said roads by the City of Nokomis as are owned by the Township, and the mayor is hereby authorized to enter into said agreement and to sign all necessary documents therefor.

INTERGOVERNMENTAL COOPERATION AGREEMENT

The undersigned municipalities, pursuant to Article VII, Section 10, of the Illinois Constitution and 5 ILCS Section 220 of the Illinois Revised Statutes, agree as follows:

SECTION 1- Purpose of Agreement

The City of Nokomis agrees to police the following roads owned by Nokomis Township, Montgomery County, Illinois: Weaver Street between Walnut Street and Oberle Street, Sherman Street, West of Cedar Street; Alley running from Sherman Street South to Oberle Street; Hamilton Street from city limit West to Sewage Disposal Plant; Franklin Street from city limit West to dead end; Roadway connecting Walnut Street to the road at baseball diamonds in Nokomis Memorial Park. City will police all above mentioned roads that are not owned by the City.

SECTION 2- Power and Authority

The undersigned Nokomis City Township does hereby authorize and direct the Mayor to enter into this agreement.

SECTION 3- Compensation

No compensation shall be paid by either party.

SECTION 4- Liability

All employee benefits, wage and disability payments, pension and worker's compensation claims, damage to, or destruction of, equipment and clothing and medical expense of the City shall be borne routinely by said City even if such obligations and losses are borne during the period in which the City is rendering substantial or extraordinary services to the Township pursuant to this agreement and the City shall indemnify and hold the Township harmless therefrom.

SECTION 5- Duration of Agreement

This agreement shall be in full effect and shall be legally binding at such time as an ordinance or resolution ratifying its execution has been passed and approved by both of the aforesaid parties, for a period of twenty years. This agreement shall automatically renew at the end of each term for a successive twenty year period.

SECTION 6- Termination of Agreement

Notwithstanding the above, either party may withdraw from this agreement pursuant to the laws of the State of Illinois by ordinance or resolution upon 90 days notice to the other party and such withdrawal shall be legally effective, if at all, upon service of a copy of such ordinance or resolution upon the clerk of the other party
