

ORDINANCE NO. 469

AN ORDINANCE PROVIDING FOR THE LICENSING OF
THE HAULING FOR HIRE OF GARBAGE, JUNK, DEAD
ANIMALS, WASTE OR REFUSE UPON THE PUBLIC HIGH
WAYS WITHIN THE CITY LIMITS OF THE CITY OF
NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery
County, Illinois;

SECTION I

It shall be unlawful for any person, firm or corporation, either
by himself or agent, to conduct, operate or carry on the business or occupation
of hauling, conveying or transporting for hire or profit or gain, or engage in
the hauling, conveying or transporting of garbage, junk, dead animals, waste
or refuse for profit or gain, within the corporate limits of said city, without
having first obtained a license therefor from the City Clerk of said City, for
which the party applying for the same shall pay to the City Clerk the sum of
Twenty Five Dollars (\$25.00) per year, payable annually in advance for each
vehicle so used or operated by him or them.

SECTION II

Any person, firm or corporation who shall conduct or carry on the
occupation of hauling, conveying or transporting garbage, junk, dead animals,
waste or refuse within the corporate limits of the City of Nokomis in violation
of the requirements of this section shall for each offense be fined in the sum of
not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00)
for each offense.

SECTION III

Any Ordinance or Ordinances of the said City of Nokomis now in full
force and effect and in conflict with this Ordinance is hereby expressly repealed.
This Ordinance shall be in effect immediately after its passage and
publication according to law.
