

ORDINANCE NO. 485

AN ORDINANCE PROHIBITING THE CONNECTION OF
SANITARY SEWERS TO ANY IMPROVEMENTS SITUATED
UPON NORTH CEDAR STREET AND CENTRAL STREET
IN SAID CITY OF NOKOMIS, MONTGOMERY COUNTY,
ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery County,
Illinois:

SECTION I. That it shall be unlawful for any person, firm or corporation
to connect any sanitary sewer from any property owned, occupied or leased by them
to any improvement situated on North Cedar Street and Central Street in the City of
Nokomis, Montgomery County, Illinois.

SECTION II. Any person, firm or corporation who shall connect any sanitary
sewer from any property owned, occupied or leased by them to any improvement situated
on North Cedar Street and Central Street in the City of Nokomis, Montgomery County,
Illinois, in violation of the requirements of this ordinance shall for each offense
be fined in the sum of not less than Twenty Five Dollars (\$25.00) nor more than One
Hundred Dollars (\$100.00) for each offense. Each and every day that a sanitary sewer
is connected from any property owned, occupied or leased by any person, firm or
corporation within said City to any improvement situated on North Cedar Street or
Central Street in said City of Nokomis, Illinois will institute a separate violation
of this Ordinance.

SECTION III. Any Ordinance or Ordinances of the said City of Nokomis now
in full force and effect and in conflict with this Ordinance is hereby expressly repealed.
This Ordinance shall be in effect immediately after its passage and publication
according to law.
