

ORDINANCE NO. 492

AN ORDINANCE PROVIDING FOR ANGLE PARKING ON THE NORTH SIDE OF THAT PORTION OF CENTRAL STREET EXTENDING FROM SOUTH CEDAR STREET EAST TO SOUTH MAPLE STREET AND PARALLEL PARKING ON THE SOUTH SIDE OF THAT PORTION OF CENTRAL STREET EXTENDING FROM SOUTH CEDAR STREET EAST TO SOUTH MAPLE STREET IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery County,

Illinois:

SECTION 1: That it shall be unlawful for any person, firm or corporation to park any motor vehicle or bicycle upon the North side of that portion of Central Street extending from South Cedar Street east to South Maple Street in the City of Nokomis, Montgomery County, Illinois, unless the same is parked in a manner angle to the curb on said North side of said street, ^{in spaces designated by the said City of Nokomis,} and that it shall be unlawful for any person, firm or corporation to park any motor vehicle or bicycle upon the South side of that portion of Central Street extending from South Cedar Street east to South Maple Street in the City of Nokomis, Montgomery County, Illinois, unless the same is parked in a manner parallel to the curb/on the said South side of said street.

SECTION 11: Any person, firm or corporation who shall park any motor vehicle or bicycle upon the North side of that portion of Central Street extending from South Cedar Street east to South Maple Street in the City of Nokomis, Montgomery County, Illinois in violation of the requirements of this ordinance shall for each offense be fined in the sum of not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense, and any person, firm or corporation who shall park any motor vehicle or bicycle upon the South side of that portion of Central Street extending from South Cedar Street east to South Maple Street in the City of Nokomis, Montgomery County, Illinois in violation of the requirements of this ordinance shall for each offense be fined in the sum of not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense.

SECTION 111: Any Ordinance or Ordinances of the said City of Nokomis now in full force and effect and in conflict with this Ordinance is hereby expressly repealed. This Ordinance shall be in effect immediately after its passage and publication according to law.
