

ORDINANCE NO. 498

AN ORDINANCE VACATING A PART OF VINE STREET IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery County, Illinois:

SECTION 1. That a part of Vine Street, in the City of Nokomis, Montgomery County, Illinois, described as follows, to-wit: Beginning at the Southeast (SE) corner of Block Twenty-two (22) in the original town, now City of Nokomis, Montgomery County, Illinois, running thence in a Northwesterly direction along the Northwesterly line of said Block Twenty-two (22) a distance of one hundred fifty (150) feet to the Southeasterly property line of the C.C.C. & St. L. Railroad Company, running thence in a Northeastly direction along the Southeasterly property line of the C. C. C. & St. L. Railroad Company a distance of Sixty-six (66) feet being the width of Vine Street in said City of Nokomis, running thence in a Southeasterly direction along the Southwesterly line of Block Twenty-three (23) in the original town, now City of Nokomis, Montgomery County, Illinois, a distance of one hundred-fifty (150) feet to the Southwest corner of said Block Twenty-three (23) which is the Northwesterly boundary line of West State Street in said City of Nokomis, running thence in a Southwesterly direction along the Northwesterly line of said West State Street in said City of Nokomis a distance of Sixty-six (66) feet to the place of beginning, situated in the City of Nokomis, County of Montgomery and State of Illinois; be vacated and the same is hereby vacated.

SECTION 2. This ordinance shall become effective upon its passage. Passed at a regular meeting of the City Council of the City of Nokomis, Illinois, held at the City Hall in said City on the 16<sup>th</sup> day of October, A.D. 1961.
