

ORDINANCE NO. 557

AN ORDINANCE ANNEXING REAL ESTATE OWNED BY NOKOMIS
COMMUNITY UNIT SCHOOL DISTRICT NO. 22, MONTGOMERY,
CHRISTIAN AND FAYETTE COUNTIES, ILLINOIS, TO THE
CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY,

ILLINOIS:

SECTION 1. That in pursuance of a Resolution duly adopted by the Board of Education of Nokomis Community Unit School District No. 22, Montgomery, Christian and Fayette Counties, Illinois, at a regular meeting of said Board of Education, held at the Unit School Office in Nokomis, Illinois, on the 8th day of December, A.D. 1966; that said Board of Education by said Resolution did recommend the annexation of the following described real estate owned by the said Nokomis Community Unit School District No. 22, Montgomery Christian and Fayette Counties, Illinois, to the City of Nokomis, Illinois, said real estate being described as follows to wit:

The North three hundred forty three and fifty six hundreds feet (343.56 F) of the West One Thousand Feet (1000 F) of Block Seventy Six (76), said premises being in P. C. Huggins and Trustees of J. R. Stanfords Addition and Outlots to Nokomis, Montgomery County, Illinois

Beginning Three Hundred Twenty Five and Six Tenths Feet (325.6 F) South of a stone at the Northwest corner of the Northeast Quarter ($NE\frac{1}{4}$) of Section Twenty-two (22) Township Ten (10) North Range Two (2) West of the Third Principal Meridian, (3rd P.M.) thence East a distance of Nine Hundred Feet (900 F) thence in a Southwesterly direction at an angle to the left of $7\frac{1}{4}$ degrees-03 minutes, a distance of Three Hundred Sixty Four Feet (364 F); thence westerly a distance of Eight Hundred Feet (800 F); thence North Three Hundred Fifty Feet (350 F) to the place of beginning situated in the City of Nokomis, Montgomery County, Illinois, and containing six acres more or less, It being the intention of said Board of Education to include in said recommendation for annexation all real estate owned by Nokomis Community Unit School District No. 22, Montgomery, Christian and Fayette Counties, Illinois, situated in Nokomis Township, Montgomery County, Illinois, and lying outside of the City Limits of the City of Nokomis, Illinois.

SECTION 111. That the City of Nokomis, Illinois, does hereby annex the above described real estate owned by Nokomis Community Unit School District No. 22, Montgomery, Christian and Fayette Counties, Illinois, to the City of Nokomis, Illinois.

SECTION IV. That the City Clerk of the City of Nokomis, Illinois, record in the office of the Recorder of Deeds, Montgomery County, Illinois, a certified copy of this Ordinance together with an accurate map of such territory.


