

ORDINANCE NO. 564

MUNICIPAL SERVICE OCCUPATION TAX

BE IT ORDAINED by the City Council of the City of Nokomis, Montgomery County, Illinois that:

SECTION I. A tax is hereby imposed upon all persons engaged in this municipality in the business of making sales of service at the rate of three-quarters of one per cent of the gross receipts received from such business, in accordance with the provisions of Section 8-11-5 of the Illinois Municipal Code.

SECTION II. Every serviceman required to account for Municipal Service Occupation Tax for the benefit of this municipality shall file, on or before the last day of each calendar month, the report to the State Department of Revenue required by Section Nine of the Sefvicce Occupation Tax Act.

SECTION III. At the time such report is filed, there shall be paid to the State Department of Revenue the amount of tax hereby imposed.

SECTION IV. The city clerk is hereby directed to transmit to the State Department of Revenue a certified copy of this ordinance not later than five (5) days after the effective date of this ordinance.

SECTION V. This ordinance shall be published within ten (10) days of its enactment as provided in Section 1-2-4 of the Illinois Municipal Code and shall be effective from and after the first day of the calendar month next following the expiration of the ten (10) days publication period.

This ordinance shall take effect on the first day of August, A.D. 1967.
