

AN ORDINANCE ADOPTING AND CONFIRMING ORDINANCE NO. 199 BEING AN ORDINANCE  
*729 x 1. E. U. B. sold into said 199*  
ANNEXING THAT PART OF J. R. WEINZER'S ADDITION AND J. R. WEINZER'S SECOND  
ADDITION TO THE CITY OF NOKOMIS, LYING CONTIGUOUS TO AND NOT EMBRACED WITHIN  
THE LIMITS OF THE CITY OF NOKOMIS, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

SECTION 1. That on the 24th day of June, A. D. 1918 and approved on the  
24th day of June, 1918, Ordinance No. 199 was passed. Said Ordinance reading  
as follows to wit:

ORDINANCE NO. 199

ANNEXING THAT PART OF J. R. WEINZER'S ADDITION AND J. R. WEINZER'S SECOND ADDITION  
TO THE CITY OF NOKOMIS, LYING CONTIGUOUS TO AND NOT EMBRACED WITHIN THE LIMITS  
OF THE CITY OF NOKOMIS, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

SECTION 1. That in compliance with the result of a legal election held in  
and for said City on Tuesday, the sixteenth day of April, A.D. 1918, that part of  
J. R. Weinzer's Addition and J. R. Weinzer's Second Addition to the City of  
Nokomis, lying contiguous to and not embraced within the limits of the City of  
Nokomis, Illinois, be and the same is hereby annexed to the said City of Nokomis,  
Illinois.

SECTION 2. The Mayor of the said City of Nokomis, Illinois, shall file a  
certified copy of his Ordinance in the office of the Recorder of Deeds of the  
County of Montgomery in the State of Illinois, together with an accurate map of the  
territory annexed by this ordinance.
