

ORDINANCE NO. 633

ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF NOKOMIS,
ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 1973 and
ENDING APRIL 30, 1974

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

SECTION 1. That the following sums be and the same are hereby appropriated out of the revenue of the City of Nokomis, Montgomery County, Illinois, for the fiscal year ending on the 30th day of April, A.D., 1974, and the specific objects and purposes for which said sums are appropriated in detail are as follows:

1. For Street and Alley Fund, appropriated as follows:
 - (a) To be used for the construction of streets and alleys\$ 1,500.00
 - (b) For repairing and improving streets and alleys 10,000.00
 - (c) For repairing and improving sidewalks and crossings 5,000.00
 - (d) For constructing bridges 1,000.00
 - (e) For repairing bridges 4,000.00
 - (f) For oiling streets and alleys 4,000.00
 - Total\$25,500.00

2. For a Salary Fund to be used to pay the salaries of the City Officers and employees, excepting firemen, policemen, and employees engaged in the maintenance and operation of the water works system\$50,000.00

3. For a Salary Fund for Policemen to be used to pay the salaries of the policemen\$33,000.00

4. For an electric fund to be used to pay for lighting the streets and alleys\$ 6,600.00

5. For Water Works Fund: for the acquisition and construction of additions, improvements, and extensions to maintenance, repair and operation of the water works system of said City, including water supply, together with all necessary labor, materials, supplies, superintendence, professional services, salaries of superintendent and employees, furnishings, equipment and supplies, expense of meter reading, delivery of bills and collection of water accounts and miscellaneous expense 100,000.00

6. For a Fire Department Fund, appropriated as follows:
 - (a) To be used in paying the firemen\$ 4,000.00
 - (b) For the purchase of equipment for the use of the fire department 3,500.00
 - (c) For the purchase of supplies for the use of the fire department..... 3,500.00
 - (d) For repair and maintenance of equipment used by fire department 2,000.00
 - Total\$13,000.00

7. For a City Prisoner Fund, to be used for the feeding of prisoners of said City\$ 100.00

8. For a Printing and Stationery Fund appropriated as follows:

20. For a Police Protection Fund, appropriated as follows:

(a) For the purpose of police protection in the City of Nokomis, as authorized by Ordinance No. 593 \$ 2,884.38

21. For a Fund for Revenue Sharing between the United States Government and the City of Nokomis, Montgomery County, Illinois, in the amount to be received from the United States Government under the Revenue Sharing Program with said City for Six (6) months, beginning with January 1, 1973 and ending June 30, 1973, the sum of SIXTEEN THOUSAND NINE HUNDRED EIGHT DOLLARS (\$16,908.00), the balance of the funds received from the United States Government under the Revenue Sharing Program for the last six (6) months will be later appropriated.

Said fund to be appropriated as follows:

1. Public Safety

(a) For sidewalk repairs and for fire protection and police protection	\$ 3,000.00
(b) A City recreational program including expenditures for the playground	1,000.00
(c) Public transportation, including street widening for Maple Street in said City of Nokomis	2,500.00
(d) Social services for the aged and poor citizens of the City of Nokomis	500.00
Total	<u>\$ 7,000.00</u>

2. Capital Improvements

(a) Machine and Storage shed, approximately 40 feet by 40 feet	\$ 5,000.00
(b) Water main extension for South Vine and Lincoln Streets	2,500.00
(c) Sewer extension for Capps Avenue, South in said City of Nokomis.....	2,500.00
Total	<u>\$ 10,000.00</u>

SECTION 11. That the sums of money appropriated by the provisions of this ordinance total Three Hundred Seventeen Thousand Two Hundred Seventy-seven and 48/100 Dollars (\$317,277.48).

SECTION 111. That any unexpended balance of any items of any appropriations made by this ordinance may be expended in making up any insufficiency in any other item of appropriations made by this ordinance.

SECTION IV. This ordinance shall be in full force and effect, as provided by law, from and after its final passage, approval and publication.
