

ORDINANCE NO. 645
AN ORDINANCE PROVIDING FOR THE INSTALLATION OF WATER METERS
AND WATER SERVICE LINES ON CITY PROPERTY IN THE CITY OF
NOKOMIS, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY,
ILLINOIS, THAT:

SECTION I. No person, firm or corporation shall hereafter install any
water meter or water service line on City property in Nokomis, without first
complying with the following regulations, to wit:

(a) The proposed water customer shall first employ a licensed plumber
or contractor to make the tap to the city main from the water meter, together
with all other necessary accessories provided by the city, at city's cost,
to the contractor or plumber. The customer upon request shall receive from
the City Clerk a copy of the bill for said materials furnished the contractor
or plumber.

(b) Before any said tap is made by said customer as aforesaid, said
customer shall apply for a permit for said tap at the City Clerk's office
in the City of Nokomis, and shall at the time of obtaining permission for
said tap from the City Clerk of said City, pay a fee of Twenty Five Dollars
(\$25.00) to the Clerk of said City, which fee shall be for the tapping of
his water service to the City main and inspection by the City of said
installation.

SECTION II. The licensed plumber or contractor shall make said tap
and shall install 3/4" copper pipe to the meter and six feet (6') beyond
the meter to the customer's service line, which line shall be of an approved
material.

SECTION III. The customer shall maintain said service line from the
water main to his property line and shall be liable for all costs of repair
of said service line, when necessary.

SECTION IV. The City of Nokomis shall furnish to the licensed plumber
or contractor employed to do said work herein for the customer all other
material needed to complete the installation of said water service from the
water main and extending a distance of six feet (6') beyond the meter.

SECTION V. No customer shall install any water service line as herein
provided until he or the licensed plumber or contractor shall furnish an

indemnity bond to the City of Nokomis in the same amount and form as all other work activities performed on City property; said bond form shall be furnished by the City Clerk of the City of Nokomis and after execution of the same, shall be filed with said City Clerk.

SECTION VI. Any ordinance or ordinances of said City of Nokomis, now in conflict with this ordinance is hereby expressly repealed.

SECTION VII. This ordinance shall be in full force and effect from and after its passage, approval and publication, according to law.
