

ORDINANCE NO. 646

AN ORDINANCE DIRECTING THE SALE OF REAL ESTATE
OWNED BY THE CITY OF NOKOMIS, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY
COUNTY, ILLINOIS:

SECTION I. That it is the opinion of the Mayor and the City Council of
the City of Nokomis, Illinois, that the following described real estate is no
longer necessary, appropriate or required for the use of or profitable to said
City of Nokomis; that said property is not being used by said City at present time.

Beginning at a point where the West property line on the West side of
Walnut Street, intersects with the South line of the Cleveland, Cincinnati,
Chicago & St. Louis Railroad right of way; thence in a Northeasterly
direction along the South line of the Cleveland, Cincinnati, Chicago &
