

AN ORDINANCE DIRECTING THE SALE OF CITY REAL ESTATE

Whereas, the City of Nokomis, Montgomery County, Illinois is the legal owner of record of all the land in the territory hereinafter described; and

Whereas, said land is vacant and is not and has not recently been used for City purposes; and

Whereas, no use of said land for City purposes is foreseen; and

Whereas, it is deemed desirable to the public interest to sell said land; and  
Whereas, a notice of the proposal to sell said real estate has been published once each week for three successive weeks in the Free Press Progress, a weekly paper published in the City of Nokomis, the first publication having been not less than 30 days before the day provided in the notice for the opening of bids for said land; and

Whereas said notice contained an accurate description of the land, stated the purpose for which it is used and at what meeting of the City Council the bids will be considered and opened; and

Whereas the bid of Eldon Deluka of 520 S. Cedar Street, Nokomis, Illinois, in the sum of Two Thousand Five Hundred Fifty One and 50/100 Dollars (\$2,551.50) for said land is determined to be in the best interest of the City;

Now Therefore, be it ordained by the City Council of the City of Nokomis, Montgomery County, Illinois,

Section 1: That the bid of said Eldon Deluka in the sum of Two Thousand Five Hundred Fifty One and 50/100 Dollars (\$2,551.50) for the land described as follows, to wit:

Part of the West Half ( $W\frac{1}{2}$ ) of the Southeast quarter ( $SE\frac{1}{4}$ ) of Section Twenty-two (22), Township Ten (10) North, Range Two (2) West of the 3rd P.M., in Montgomery County, Illinois, more particularly described as follows: Commencing at the Southeast Corner of the aforesaid Section 22; thence Westerly along the South line of said Section 22, 1027 feet to the East R.0.W. line of Gipson Street as recorded in Miller's Division of Blocks Five (5), Six (6), Seven (7), Eighteen (18), Nineteen (19), Twenty (20), Twenty-one (21), Twenty-two (22), and part of Blocks Nine (9) and Seventeen (17) in Randall & Miller's Subdivision; thence Northerly along said East R.0.W. line 567.5 feet, more or less, to the intersection with the North R.0.W. line of Cherokee Street in Miller's Division, extended, said intersection being the true point of beginning; thence continue northerly along the East line of Gipson Street, 130 feet; thence East 150 feet, thence North 95 feet, thence East 321 feet more or less to the West line of Block 10 of the aforesaid Randall and Miller's Subdivision, thence South along the West line of said Block 10, 225 feet, thence West 471 feet more or less to the true point of beginning, situated in the City of Nokomis, Montgomery County, Illinois,

is hereby accepted.

Section 2: That upon receipt of the consideration therefor, the Mayor and City Clerk of the City of Nokomis are directed to convey the said land and transfer it, by a proper deed of conveyance, stating therein the consideration therefor.

Section 3: That this ordinance shall be in full force and effect from and after its passage and approval.
