ORDINANCE NO. 760

AN ORDINANCE AMENDING ORDINANCE #742, ENTITLED  
"AN ORDINANCE RELATING TO THE RETAIL SALE OF ALCOHOLIC LIQUOR  
IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS."

WHEREAS the consumption of alcoholic beverages on public streets in the vicinity of taverns, bars and similar establishments for the sale of alcoholic beverages, situated in the City of Nokomis, has become increasingly prevalent in recent months;

AND WHEREAS there is a consensus among the commissioners of the City of Nokomis that such public consumption upon property adjacent to, or in the immediate vicinity of, such establishments has alarmed or become opprobrious to city residents in general;

AND WHEREAS the said commissioners have concluded that the licensees of such establishments have, as a practical matter, the power to control such public consumption attendant the sale of such alcoholic beverages within the interior of their respective establishments,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL  
OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS:

Section 1. That subparagraph (a) of Section 20 of City of Nokomis Ordinance No. 742 shall be, and is hereby, amended to provide

"Section 20. SALE TO MINORS, DRUNKARDS, ETC.  
(a) No licensee nor any officer, associate, member, representative, agent or employee of such licensee shall sell, give or deliver alcoholic liquor to any person under the age of 21 years, except as hereinafter provided in this chapter or to any intoxicated person or to any person known by him to be a habitual drunkard, spendthrift, insane, mentally ill, mentally deficient or in need of mental treatment. No person, after purchasing or otherwise obtaining alcoholic liquor shall sell, give or deliver such alcoholic liquor to another person under the age of 21 years, except in the performance of a religious ceremony

or service, except as hereinafter provided. Neither shall any licensee nor any officer, associate, member, representative, agent or employee of licensee permit the consumption of alcoholic beverages by any patron upon the public thoroughfare adjacent to, or in the immediate vicinity of, the said licensee's establishment following the sale of such beverage to such patron by the said licensee or licensee's representative as aforesaid."

Section 2. That all ordinances, resolutions and orders, or parts thereof, in conflict herewith, be and the same are hereby repealed and that this ordinance be in full force and effect forthwith upon its adoption, approval and publication, as provided by law.
