

*Ordinance No. 764*

AN ORDINANCE OF THE CITY OF NOKOMIS  
PROVIDING FOR THE LEVY OF A TAX IN 1997  
FOR THE PAYMENT OF PRINCIPAL OF AND  
INTEREST ON BONDS OF THE CITY OF NOKOMIS

WHEREAS, on February 22, 1988 the City Council passed and approved an Ordinance entitled "An Ordinance Providing for the Borrowing of Money in Issuing General Obligation Bonds of the City of Nokomis, Montgomery County, Illinois, in the Amount of \$100,000, and Providing for the Levy and Collection of a Direct Annual Real Estate Tax for the Payment of Principal and Interest of Said Bonds"; and,

WHEREAS, Section 7 of said Ordinance provided for the levy of a real estate tax upon all taxable property within the City of Nokomis; and,

WHEREAS, said Section of said Ordinance failed to levy a tax for the year 1997 to produce a sum of money sufficient to pay principal of and interest on bonds maturing in 1998; and,

WHEREAS, it is necessary that said tax be levied to provide for the payment of bonds maturing in 1998.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

Section 1. That the City Council hereby finds and determines that the facts and statements contained in the Preamble to this Ordinance are true and correct and hereby adopts the same as part of this Ordinance.

Section 2. That for the purpose of providing funds required to pay principal and interest on General Obligation Bonds (the "Bonds") issued by the City of Nokomis pursuant to Ordinance No. 762 which mature in 1998 there be and there is hereby levied upon all the taxable property in said City, in

addition to all other taxes, a direct annual real estate tax for the year 1997 in an amount sufficient to produce the sum of \$15,555 for principal and interest.

Section 3. The deposit of and expenditure of funds collected pursuant to the tax levied by this Ordinance shall be deposited and expended in accordance with the provisions of Ordinance No. 762 passed and approved by the City Council on February 22, 1988.

Section 4. That forthwith as soon as this Ordinance becomes effective, a copy hereof certified by the Clerk of said City, which certificate shall recite that this Ordinance has been passed by the City Council of said City and published, shall be filed with the County Clerk of Montgomery County, Illinois, who shall in the year 1997 ascertain the rate percent required to produce the aggregate tax hereinbefore provided to be levied in 1997 and extend the same for collection on the tax book in 1997 in like manner as taxes would be levied by the City for general corporate purposes, and in the year 1997 such an annual tax shall be levied and collected by said City in like manner as taxes would be levied and collected for general corporate purposes for the year 1997, and when collected, such taxes shall be used solely for the purpose of paying principal of and interest on the Bonds authorized and issued by Ordinance No. 762.

Section 5. That the funds derived from the levy made herein and be and the same are hereby appropriated and set aside for the sole and only purpose of paying principal of and interest on the Bonds authorized and approved by Ordinance No. 762 when and as they become due.

Section 6. That in the event the amount of funds collected from the real estate tax levy provided for herein exceeds the amount required from such levy to pay and discharge the principal and interest on said Bonds, the City

Council shall adopt a Resolution and timely file the same with the proper authorities requiring abatement of the tax levy provided for herein to the extent of such excess funds collected.

Section 7. That the City Council hereby adopts and incorporates by reference Sections 10 through 18 of Ordinance No. 762 as if set forth fully herein, to the extent that such provisions affect the levy, collection, deposit, investment or expenditure of the proceeds of the levy herein provided.

Section 8. That all ordinances, resolutions and orders, or parts thereof in conflict herewith, be in the same or hereby repealed, except that no provision of this Ordinance shall operate to repeal any provision of Ordinance 762, and this Ordinance shall be in full force and effect from and after its passage, approval and publication is provided by law.




