

ORDINANCE NO. 798

AN ORDINANCE REGULATING
PARKING ON STATE STREET
IN THE CITY OF NOKOMIS
MONTGOMERY COUNTY, ILLINOIS

WHEREAS, the city of Nokomis has entered into an agreement with the State of Illinois for the improvement of State Street, Illinois Route 16, from Township Road 123B, west of Nokomis, to Township Road 510B, east of Nokomis, to be known as F.A.P. Route 325, State Section 18RS-2, 19RS-4, City Section 93-00023-00-RS; and

WHEREAS, in compliance with the aforesaid agreement, it is necessary for the city of Nokomis to adopt and put into effect an ordinance regulating parking on State Street;

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, THAT:

Section 1. Parking be prohibited on State Street from the west corporate limits to Cedar Street and from Elm Street to the east corporate limits and on the north side of State Street from Oak Street to Elm Street.

Section 2. Parking be parallel to the curb and in the direction of the traffic in the adjacent lane, on the south side of State Street from Oak Street to Elm Street.

Section 3. Any person, firm, or corporation violating the provisions of this Ordinance shall be fined, not less than *Ten* dollars (\$*10.00*), nor more than *One Hundred* dollars (\$*100.00*) for each offense, and a separate offense shall be deemed committed for each and every day during which a violation continues or exists.

Section 4. All ordinances or parts of ordinances in conflict with the provisions of this ordinance shall be, and the same are, to the extent of such conflict, hereby repealed.

Section 5. This Ordinance shall be in force and effect after its passage, approval, and publication as required by law.

ORDINANCE NO. 694

AN ORDINANCE PROVIDING FOR PARALLEL PARKING ALONG STATE STREET AND SPRUCE STREET, IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS

BE IT ORDAINED by the City Council of the City of Nokomis, Montgomery County, Illinois, that;

Section I: It shall be unlawful to park or cause to be parked, any vehicle along Illinois Route 16 on State Street, from Oak Street to Cedar Street inclusive, and on Spruce Street, northerly from State Street for a distance of 125 feet, on either side of the street, except that such vehicles be parked parallel to the curb with the direction of traffic on the street.

Section II: Any person or firm violating this ordinance shall be fined not less than ~~TEN~~ TEN dollars, nor more than ~~ONE HUNDRED~~ TEN dollars for each offense, and a separate offense shall be deemed committed for each and every hour during which a violation continues to exist.

Section III: If any Section, paragraph, clause or other provisions of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section IV: This Ordinance shall be published 1 time(s) the day after its passage, in the FRAN PRESS, a newspaper having a general circulation in the City of Nokomis, Illinois.
