AN ORDINANCE AMENDING SECTION 24-6-3 OF THE MOTOR VEHICLE CODE

Be it ordained by the City Council of the City of Nokomis, Illinois, that:

Section 24-6-3 (C) as well as Schedule "I" and "I-1" of the Motor Vehicle Code of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by adding thereto the following:

Schedule "I"
NO PARKING ZONE

STREET-DIRECTION

LOCATION

Central Street (both) from

Beginning at Pine Street and ending at a point 150 feet East thereof

Schedule "I-1" shall be amended by adding thereto the following:

Schedule "I-1"
Angle Parking

STREET-SIDE

LOCATION

Central Street (North)

From Cedar Street to S. Maple Street, except as indicated in Schedule "I" where parking is prohibited 150 feet East of Pine Street.
