NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS AS FOLLOWS:

1. That the following described territory being indicated on an accurate map of the annexed territory, which is attached hereto, is hereby annexed to the City of Nokomis, Montgomery County, Illinois:

Lots 13 through 18 of Block 2 and Lots 3 through 9 and 13 through 16 of Block 1 of the North School Addition, Nokomis, Illinois; and

Lots 109 through 129 of Kettelkamp's Addition, Nokomis, Illinois.

2. That the City Clerk is hereby directed to record with the Recorder and to file with the County Clerk of Montgomery County, a certified copy of this Ordinance, together with the accurate map of the territory annexed and attached to said Ordinance.

3. That this Ordinance shall be in full force and effect

from and after its passage, approval and publication in pamphlet form as provided by law.
