Schedule "O" of Section 24-6-4, Parking for the Handicap, of the Revised Code of Ordinances of the City of Nokomis, Illinois, shall be amended as follows:


SCHEDULE "O" HANDICAPPED PARKING AREAS

In accordance with the provisions of Section 24-6-4 the following parking spaces are hereby designated as handicapped parking areas, to-wit:

LOCATION

1. One space in the parking lot of the Nokomis Community Complex located at 22 South Cedar, Nokomis, Illinois.
2. One space located in front of the First National Bank of Nokomis, 122 West State, Nokomis, Illinois.
3. One space located in front of Alice's Restaurant, 118 East State, Nokomis, Illinois.
4. One space located in front of the United States Post Office, 121 South Pine, Nokomis, Illinois.
5. One space located in the City parking lot next to Debbie's Time Out Cafe located in an alleyway between State Street and Central Street.


