Article IV - Coin Operated Machines of the Business Code of the Revised Code of Ordinances in the City of Nokomis, Illinois shall be amended as follows:

- 7-4-2 <u>LICENSE REQUIRED</u> No person, firm or corporation shall engage in the business of an operator as herein defined without first having obtained license therefore. The license shall begin on May 1st each year and expire on the last day of April of each year.
- 7-4-3 OPERATOR'S LICENSE FEE The license fee for each operator shall be Thirty-five (\$35.00) per year for each machine, except pool tables and juke boxes, payable in advance.

7-4-4 MACHINE FEE Deleted

All other provisions of Article IV of the Business Code shall remain in full effect as stated.
