**ORDINANCE VACATING STREET**

Be it ordained by the City Council of the City of Nokomis, Illinois that,

Pursuant to Statute, in particularly, Illinois Compiled Statutes, 65 ILCS 5/11-91-1 et seq, that the following alley, of the City of Nokomis, Illinois, is hereby vacated and abandoned by the City of Nokomis, and the city has determined that the vacation of said portion of such alley is in the best interest of the City for the reason that said public alley has not been maintained or reconstructed in recent years and it is desirable to relieve the public from further burden and responsibility of installing, constructing, or maintaining said portion of said street, as described below;

An alley located on that certain Block located in Miller & Young's Addition to the City of Nokomis, Montgomery County, Illinois, containing Lots 1 through 14 in Block 1 and being bordered by Miller St. on the North, Capps Ave. on the West, Union St. on the South and Blue St. on the East.

Passed by an affirmative vote of three-fourths or more of the members of the City Council and approved by the Mayor of the City of Nokomis, Illinois on this 9th day of August, 1999.

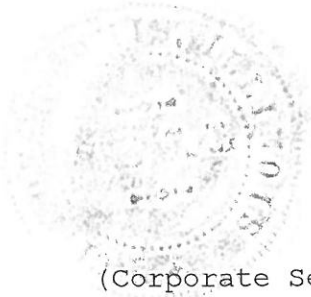


