AN ORDINANCE VACATING A NEVER DEVELOPED ROADWAY RUNNING NORTH AND SOUTH LOCATED SOUTH OF ILLINOIS ROUTE 16, NORTH OF A PREVIOUSLY VACATED ROADWAY FORMERLY KNOWN AS RANDALL STREET, IN THE CITY OF NOKOMIS, ILLINOIS

WHEREAS, the City of Nokomis, Illinois (the "City") an Illinois non-home rule municipal corporation pursuant to Article VII, § 8 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

WHEREAS, Section 11-91-1 of the Illinois Municipal Code (65 ILCS 5/11-91-1) provides that the corporate authorities of a municipality may by ordinance vacate any street or alley, or part thereof, within their jurisdiction after determining that the public interest will be subserved by said vacation; and

WHEREAS, Section 11-91-1 of the Illinois Municipal Code (65 ILCS 5/11-91-1) provides further that a notice of public hearing and the conduct of a public hearing is required before a vacation ordinance can be enacted if the street or alley under the municipality's jurisdiction is located in an unincorporated area, but no such notice and hearing is required if the street or alley is located in an incorporated area of the municipality; and

WHEREAS, the street or alley to be vacated herein is located in an incorporated area of the City; and

WHEREAS, the corporate authorities of the City have determined that the fifty feet (50') wide never developed roadway that runs north and south from the South line of State Route 16 to the North line of the previously vacated Short Street is no longer necessary, appropriate, or required for the use of or profitable to the City of Nokomis and that the public interest will be subserved by the vacation of the roadway, including, but not limited to, the relief to the City from further burden and responsibility of maintaining the roadway, or part thereof, said roadway being depicted on the Plat of Survey attached to this Ordinance as "EXHIBIT A"; and

WHEREAS, the corporate authorities of the City have determined this street or alley was originally surveyed, platted, and dedicated as a roadway, formerly known as Randall Street, but was never developed or maintained as a street or an alley or used by the public, and that Randall Street was previously vacated, except for that portion identified in the preceding paragraph; and

WHEREAS, the parcels abutting upon the roadway are P.I.N. 08-22-403-001 and a portion of P.I.N. 08-22-454-012 to the east and P.I.N. 08-22-454-012 to the west, which parcels are presently owned by the City; and

WHEREAS, at least three-fourths of the corporate authorities now holding office has determined the public interest would be best served if the said roadway is vacated, and that the parcels abutting the said roadway to the east and to the west should acquire title to the said roadway.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Nokomis, Illinois.

SECTION 2: Pursuant to Section 11-91-1 of the Illinois Municipal Code, 65 ILCS 5/11-91-1, the City hereby vacates the following described roadway, said roadway being depicted on the Plat of Survey attached to this Ordinance as "EXHIBIT A":

All that part of the 50 feet wide roadway lying west of and adjacent to Lots One (1) through Sixteen (16) in Block One (1) in Miller's Division of Blocks 5, 6, 7, 18, 19, 20, 21, 22 and

Part of Blocks 9 and 7 in Randall and Miller's Subdivision in the City of Nokomis, Montgomery County, Illinois.

SECTION 3: The City of Nokomis shall retain an easement as particularly described in the Plat of Survey ("**Exhibit A**" hereto) as "Land Surveyor Description of Proposed Water Line Easement".

SECTION 4: The City of Nokomis does hereby and herewith and shall hereafter retain easements as may be necessary and desirable, in the judgment of the City, for the continuance, renewal, servicing, maintenance, and reconstruction or relocation of public or private utility facilities, including, but not limited to, water, gas, electric, sewer, storm sewer, cable, and telephone.

SECTION 5: The permanent index numbers of the land abutting the east one-half (1/2) of the roadway described above are as follows:

P.I.N. 08-22-403-001 & 08-22-454-012

The permanent index number of the land abutting the west one-half (1/2) of the roadway described above is as follows:

P.I.N. 08-22-454-012

SECTION 6: Upon vacation of the above-described alleyway, title to the east one-half (1/2) of the roadway shall be acquired and vest in the record owner of the land abutting the east side of the vacated alley (*i.e.*, the City) for the extent of the common borders of their respective parcels with the said alleyway, and title to the west one-half (1/2) of the roadway shall be acquired and vest in the record owner of the land abutting the west side of the vacated alley (*i.e.*, the City) for the extent of the common borders of their respective parcels with the said alleyway.

SECTION 7: This Ordinance shall be recorded by the City Clerk with the Recorder of Deeds of Montgomery County, Illinois, and the Mayor of Nokomis is hereby authorized to do any and all things reasonable, necessary, and proper to accomplish the closing and vacation of said alley as a matter of public record and as provided by law.

SECTION 8: All ordinances, resolutions, motions, or parts thereof in conflict with this Ordinance are hereby superseded, and this Ordinance shall be in full force and effect upon its adoption, approval, and publication as required by law.

SECTION 9: The Mayor is authorized and directed to sign and the Clerk is authorized and directed to attest to this Ordinance.


